

# **PNC THUNDER IN THE VALLEY**

## **MOTORCYCLE RIDER WAIVER AND RELEASE FORM**

As consideration for being allowed to participate in any PNC Thunder in the Valley organized rides, now or in the future, whether scheduled or impromptu, I hereby agree as follows:

I freely, on behalf of myself, my heirs, successors and assigns, fully and finally release PNC Thunder in the Valley and Puyallup Church of the Nazarene, and their directors, officers, employees, ride organizers, sponsors, representatives, agents and volunteers, and hold them harmless from any and all claims, demands, suits and/or liability of any kind, whether known or unknown, fully, finally and forever, arising or resulting from my participation in, or attendance at, any PNC Thunder in the Valley ride or event. I hereby fully and finally waive any such claim, known or unknown, which may arise.

In signing this document, I represent that I am fully knowledgeable of the danger and hazards associated with riding motorcycles and I choose to assume such risk. I certify that I am duly licensed, insured and competent to operate a motorcycle in a safe manner, and the vehicle is in a safe operating condition. I acknowledge that I will be riding on public roads and highways among traffic and that I am solely responsible to determine the speed and operational characteristics of my motorcycle while participating in the ride. I hereby release PNC Thunder in the Valley and Puyallup Church of the Nazarene, and their directors, officers, employees, ride organizers, sponsors, representatives, agents and volunteers, and hold them harmless from any and all claims, causes of action, or any other liability of any kind arising from my operation of a motorcycle. I hereby fully and finally waive any such claim, known or unknown, which may arise.

I certify that I have no known physical or mental impairment that may affect my safety or the safety of the group and that I am 18 years old or older. I understand that the choice of wearing a helmet or other protective gear is solely my own and that I am responsible for my compliance with all state laws, including those regarding helmets. I certify that I am not under the influence of any narcotic, alcohol, or other drug that may impair my understanding or judgment and that I will not at any time during the ride operate my motorcycle under the influence of any drug or alcohol. I also understand that this Waiver and Release is in force for the duration of any ride or event I participate in and that it covers any and all activities.

I certify that I possess a valid driver's license with a motorcycle endorsement and I agree to provide a copy of such license along with this form. I certify that I have valid liability insurance that complies with the requirements of the laws of the State of Washington and I agree to provide proof of insurance along with this form.
